A By-Law to Repeal By-Laws

1. Short Title

This By-Law shall be known as A By-Law to Repeal By-Laws and shall be cited as the “Repeal By-Law”.

2. Repeal of By-Laws

WHEREAS it is deemed by the Council of the Municipality of the District of Digby that certain By-Laws of the Municipality of the District of Digby are out-dated or otherwise no longer necessary.

THEREFORE, BE IT RESOLVED that the following By-Laws are hereby repealed:

- h) Committees By-law (repealed August 21, 2002)
- i) Nomination, Finance & Public Accounts By-law (repealed August 21, 2002)
- j) Taxi By-law (repealed August 21, 2002)
- k) Recreation By-law (repealed August 21, 2002)
- l) By-law Relating to Sewers dated October 1, 1984 (repealed June 25, 2007)
